Taxbrowser is a secure site that can be accessed over the Internet with a standard web browser. This one site has the information you need to conveniently search, sort, and view payroll tax data, at any time. Taxbrowser puts you in control. It is the simple, user-friendly portal that keeps you informed and in control of daily Payroll Tax activity.

With Taxbrowser you can:

- Complete Client conversion documents online (Service Bureau clients only)
- View payment confirmation of Federal, State, and Local tax deposits
- View Tax and Fee collections
- Export tax data to Excel[®]
- View, save, and print Quarterly and Annual Summaries
- View Tax ID numbers and rates on file
- Track Notice resolutions
- Sort data by: Check Date, Collection Date, Tax Type, or Payment Date

Online Client Conversion Tool (Service Bureau Clients only)
